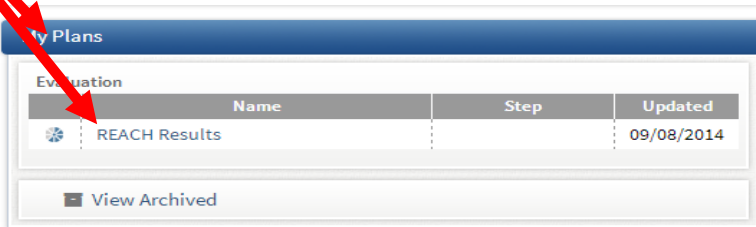




Reflect and Learn System: Accessing the Consent Form to Share REACH Results with CTU

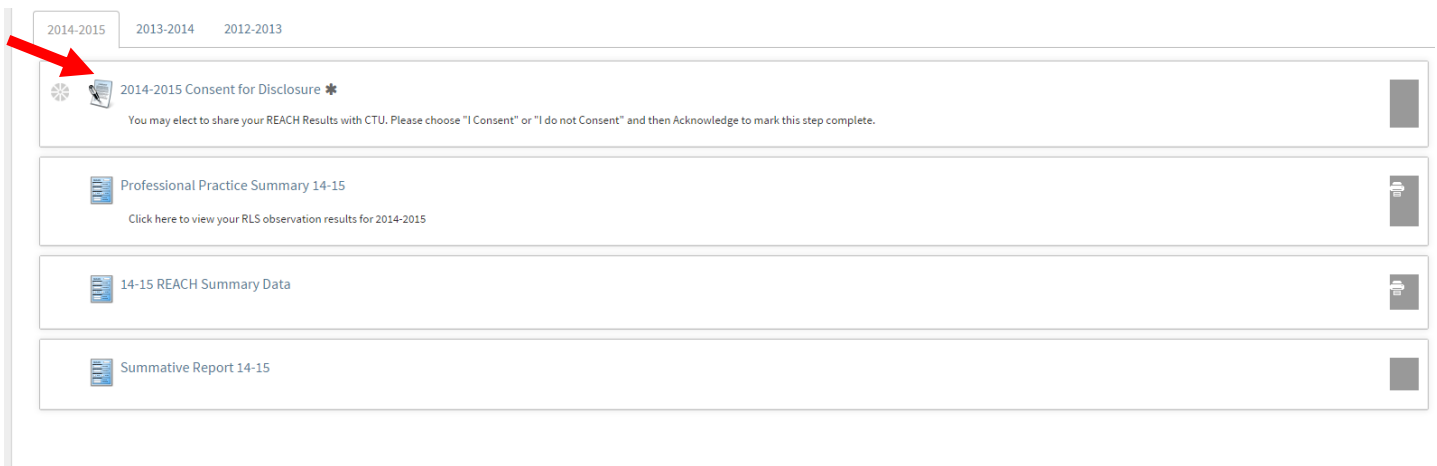
Step 1:

Consent for Disclosure of SY 2014-15 Individual Summative Performance Evaluation Results to the Chicago Teachers Union and Release of Claims

Understand and acknowledge that:

1. Section 24A-7.1 of the Illinois School Code states that disclosure of public school teacher and principal performance evaluations is prohibited.
1. Section 11 of the Personnel Records Review Act states that the disclosure of performance evaluations under the Freedom of Information Act shall be prohibited.
1. The Chicago Teachers Union (CTU) has asked the Board of Education of the City of Chicago (CBOE) to share my summative evaluation results, including scores for each of the teacher practice and student growth measures and the overall summative score and performance level with the CTU. CBOE has agreed to do so only if:
 1. I voluntarily consent to and permit CBOE to disclose my summative evaluation to CTU.
 2. Each consent is related to one summative performance evaluation.
 3. CTU agrees not to disclose the summative evaluation results to any third party.
 4. I release the CBOE and its employees and agents from any liability arising out of the disclosure of or transmission of my summative evaluation results to the CTU.
1. The Chicago Teachers Union (CTU) has also asked that, in the event I am rated unsatisfactory and file an appeal of my rating, the CBOE to share the information provided to the Joint Appeals Committee regarding my evaluation. CBOE has agreed to do so only if:
 1. I am rated unsatisfactory.
